President's Report- Byron Holtzen

Byron thanked all instructors for teaching at these hot months. The next meeting is in October where we will be nominating officers and board members. It needs to be determined which will be open yet. Please let Byron know if you are interested in being on the nominating committee. Chuck is stepping down as Registrar and this position needs to be replaced.

VP/Membership Report - Karen Schlipf

Peter McCafferty has applied as a new member. He lives in Lake Geneva- they are snowbirds in FL and would not mind volunteering as possible. He is a past member with his dog Mattie. Joan commented that he is a great guy. Liz motioned to accept. Chuck seconded. All were in favor.

Treasurer Report- Shawn Hacker

Shawn reviewed the report and had hardcopies for those in attendance. We have a total in all accounts of \$74,490.66. Note that we have paid for the fairgrounds for the trial.

A credit card for the club was too difficult to do. The opened a small account with a debit card for \$3000.00. Byron has a card and so does Shawn.

The accountant is reviewing and starting with what was approved in the last meeting to iron out our finances and will get back to Shawn as possible.

Director of Training Report-Liz Hixon

All is going well. New puppy class starts on Monday with Nikki and Chuck that has just filled. We have Monday class of Beginner 1 taught by Susan and Pat. New novice 8 week class that Joan is teaching- one pesson may join late. Tuesday ring rental and Rally: Rally is doing well. Open class on Tuesday is sign up on line for 8 students maximum per night. This is an class for teaching open and brought back people who were training before. We had an instructor's bbq this past Sunday for brainstorming and sharing the history of each instructor- we shared ideas and good food. We will seek to do a instructor's meeting quarterly for discussion of consistency in training.

Registrar's Report - Chuck Holtzen

Byron noted that Chuck does 3-5 hours weekly but then spends 20 hours weekly to get students registered. There is a lot of follow up from/with the students.

We the had opportunity to train in July since the fair was canceled but the challenge is that it changes the scheduling for the rest of the year for the class timing so taking July off is a better plan. Classes are filling up as Liz has noted. Chuck was curious in looking at finances and found year ago in January since that point in time, we have \$46,261.00 collected online. Despite a small amount of refunds under \$1,000- firm opinion that the club would have folded as there was no way to do what we have done with

COVID without online bookings. Last 365 days we made \$30,884.00 so it could be probably higher than that but the website registration has led to an **excellent increase in revenue.** There was to be a wait list that was possible but it caused a glitch and created a whole new class and Gail graciously accepted teaching two classes. There are a lot of inquiries. Liz is tweaking the descriptions of the classes but Chucks forwards emails to Liz to answer. Online registering and the COVID form signs are on the website. When she clicks on a person's name, there is much info that has been made available along with the ability to upload health certificate and to track what students have done. All thanked Chuck- she had to run to another meeting.

Secretary's Report- Joan Mazat

All AKC emails and information has been sent to the respective chairs.

Trial Chair - Carole Moen

She has one rally trial approved. Obedience- with running the two trails, she is challenged with the ring lay outs. Next year all the requirements and deadline restrictions for AKC will be inforced so we will need to go back to being compliant. For next year- judges cannot judge a trial for 30 days within 100 miles. Keep this in mind as we find judges. For decision making for next year we need to analyze if we made money or not. Carole will not chair next year as she needs to be at the trial for three days. This year Pat is assisting to be at the trial. We have Bob Olson as Trial Secretary. Sandra Gould and Loretta Lazzara will Judge Friday Rally. Obedience Judges are Loretta Lazzara, Jim Comuale, and Suzanne Maybourne.


Byron Opened the Floor to General Comments-

An immediate reply came from the hotel owner, who wrote:


