Many people were voicing their worries about the toys on the course. "Oh man, we haven't seen that in a while" and "Oh no, I hope he doesn't grab the toys". Hearing this ring side and the many concerned voices, this can creep into your mind as it did mine that day. I had Blue, a veteran, a Utility Dog- he's seen many a toy in his day on the course and here we are, and he's on a roll with first place for legs 7 & 8 in Master Classes he was entered in. We practice all the time and his leave it on toys on the ground is solid. But the worry crept in... voices leading to doubt... vision of Blue locking on the toys and not giving them up. As we were working the course, Blue was doing just fine, having fun! We nailed the figure 8 with distractions but had to circle back right near the toys for moving down, walk around dog, something he does beautifully. The worried returned. Instead of downing and me walking around, I stopped when he downed. IP- 10-point deduction, no redo in Masters! What would have been a 95 with a placement turned into an 85 due to handler error created by silly worry and lack of trust in my partner. Still a Q and a title, but seeing this as our leg, the placement would have been sweet. Moral to the story, be prepared when you enter, know your signs, **guide your partner with confidence** as he relies on your direction and clarity, and **trust him to do the right thing.... And he will! It's a matter of trust!**

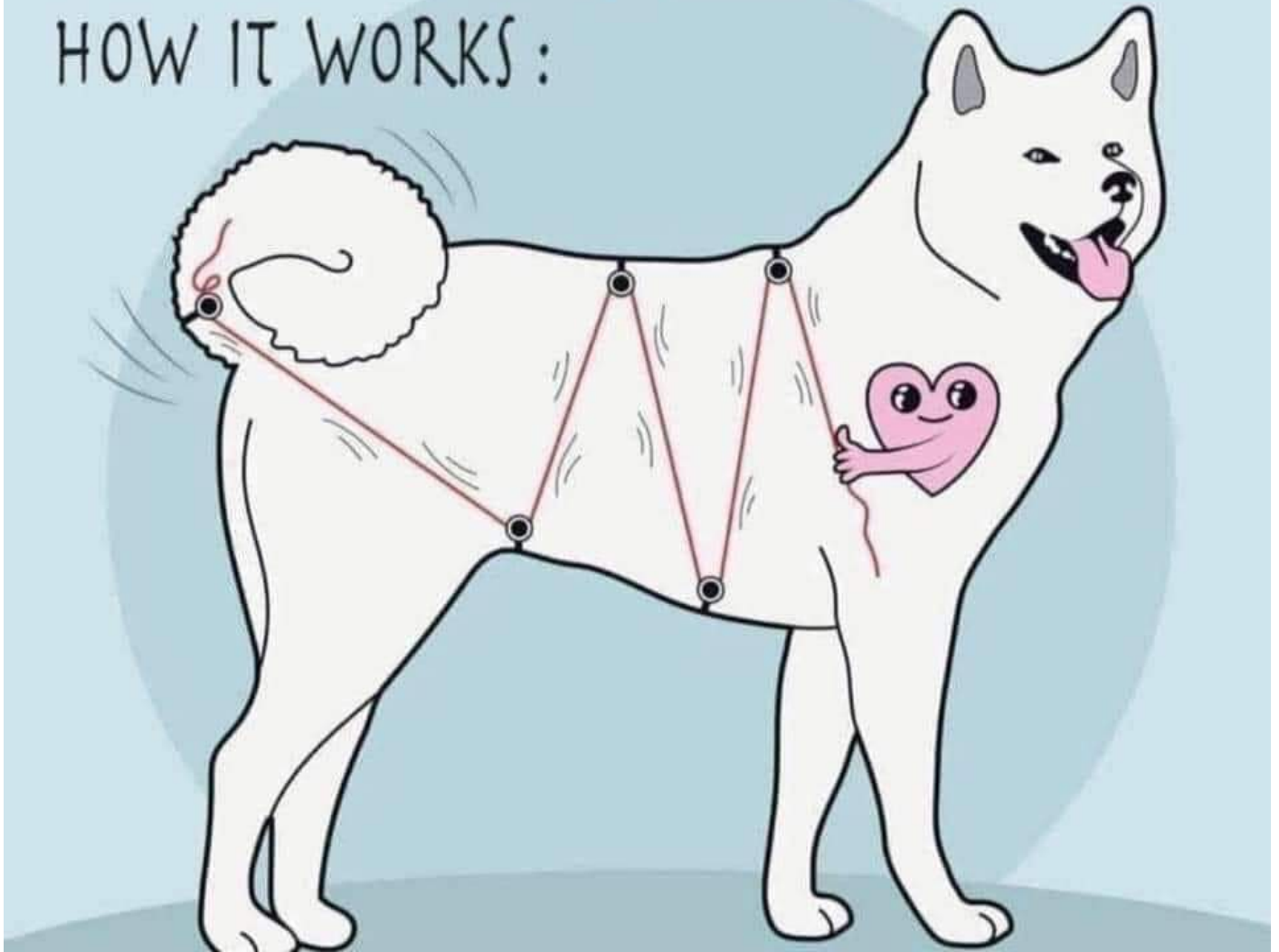

1.Call to Order 7:05

2.Previous meeting(s) minutes

1. Joan read the minutes. Byron made a motion to accept. Chuck Holtzen seconded. All were in favor. Motion passes.

3.Officer Reports

1.President (Byron Holtzen)

1. The Board is meeting monthly. Anyone who would like to attend, please let us know so we can send the invite.
2. There is a board position candidate to fill the open position and we will discuss this at the next board meeting.
3. Missed one of the goals which is a budget for this year. It will be ready for the next meeting.

2.Vice President (Karen Schlipf)

1. Getting Membership roster up to date, steady from last report and getting ready to send off to AKC. 68 total members including the lifetime members. We were over 100 two years ago, 84 last year so we need to build back up.

3.Treasure (Shawn Hacker)

1. Profit from the agility trial that was approximately \$2,600.00
2. Rent is due at the Fairground March 1st.
3. We are over \$3,000.00 ahead this month.
4. Tuesday night is at no charge to us for training.
5. The combined total of accounts is \$74,943.11.

4.Director of Training (Liz Hixon)

1. We have a new session of beginner 1 and 2 and from both instructor's things look good so far and the students should progress nicely. 8 teams per class and going well.
2. Tuesday nights are ring rental and rally run throughs



1. March 2nd, we have a match. Due to being able to only use one building one hour of novice and UD and then the second hour rally and open.
 2. Sheriffs training will be in building 3 so we are restricted to one side of the building next weeks.
 3. Voting training March 8-15 in building 2 so we will be in building 3 with only two rings. Dean and Cheri will correct the ring set up.
 4. We will be able to enter through gate S7 which is between the school and the fairgrounds.
 5. She was hoping to start early training but building 1 is a mega vaccine center so we need to wait due to the filled parking lot until we can configure parking.
 6. Beginner 1 was the class requirements CGC but the students were not ready so shifted to Beginner 2 to allow for better success.
 7. We hope to have 2 beginner 2 classes in April. Another instructor and assistants are needed for 8 students.
 8. 2 puppy, 2 Beginner 1 and 2 Beginner 2 classes will be starting.
 9. Snowstorm lost the off day between starts.
2. Registrar (Chuck Holtzen)
1. Registrations have been going well.
 2. Puppy classes were filling up fast but now they are slow to fill up and the beginner 1 class filled and folks were scrambling to get in.
 3. We are retaining over half of the puppies to Beginner 1 and then Beginner 2 is a required class, so they are filling.
 4. Puppy classes were still restricted to 6 puppies.
 5. Students are somewhat concerned about how many people are in the classes. Having smaller classes allow for social distance
 6. Beginner 2- last class is the CGC test and it is included in their fee.
 7. Due to the snow day the CGC test will be on a Tuesday April 27th and there can be two tests going at the same time and we will capture the past students to come back and take the test that missed it during the closure.
 8. We had less than \$200 in refunds due to the last pandemic "pause".
 9. Puppy starts in April.
3. Secretary (Joan Mazat)- report made prior.
4. Board Member Reports/Comments or Questions- Candy Ellis asked about the summer picnic and the Christmas party. Picnic is the end of June – discussion was had it would depend on the pandemic so we can plan for June 28 and see what happens. Would decide in April.

- 1.Match (Cheri Nicholas, Joan Mazat)- Joan encouraged everyone to come to the match and the benefit of having the schedule of knowing when to be there. Trainers coming on Tuesday are really enjoying their time and progressing.

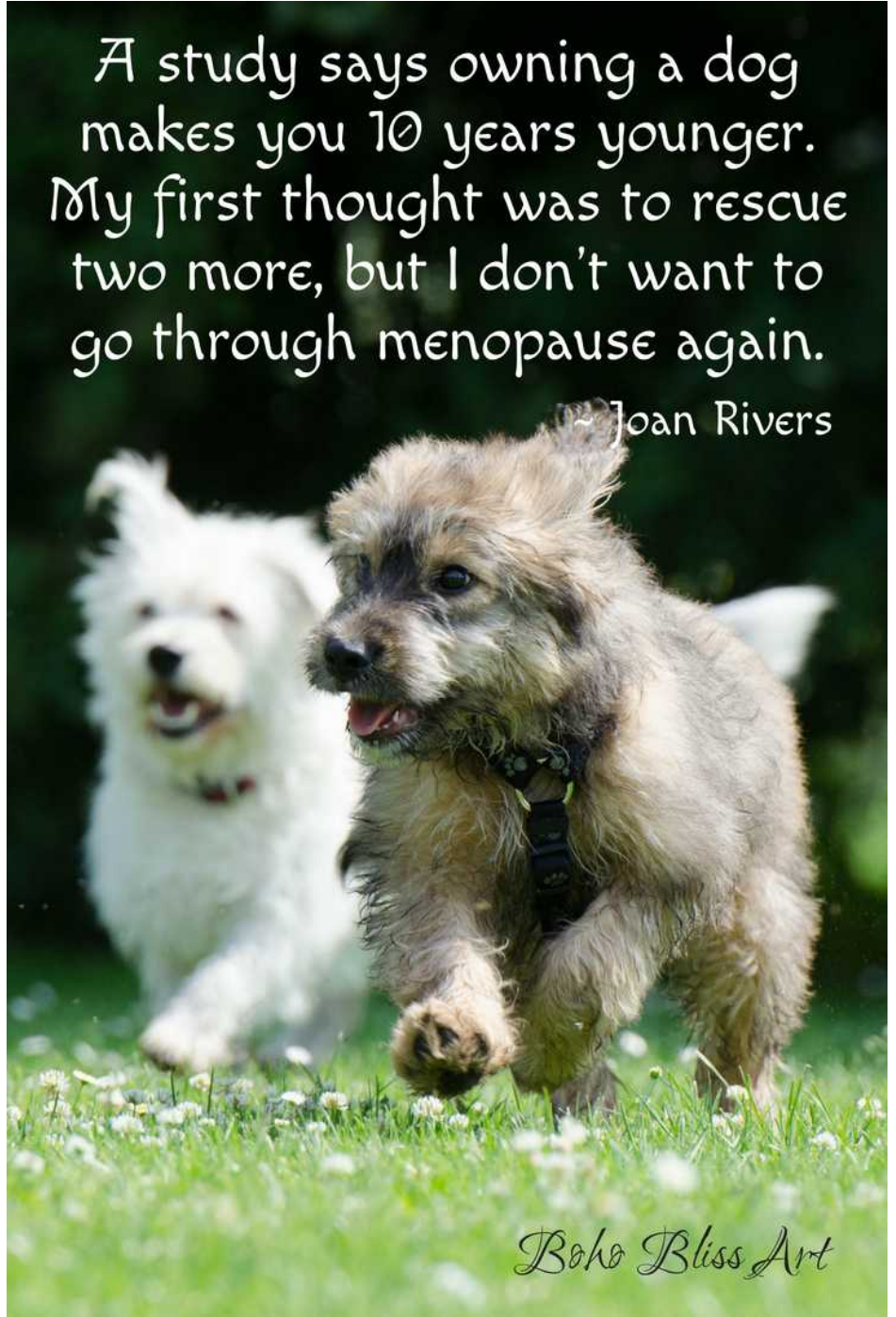

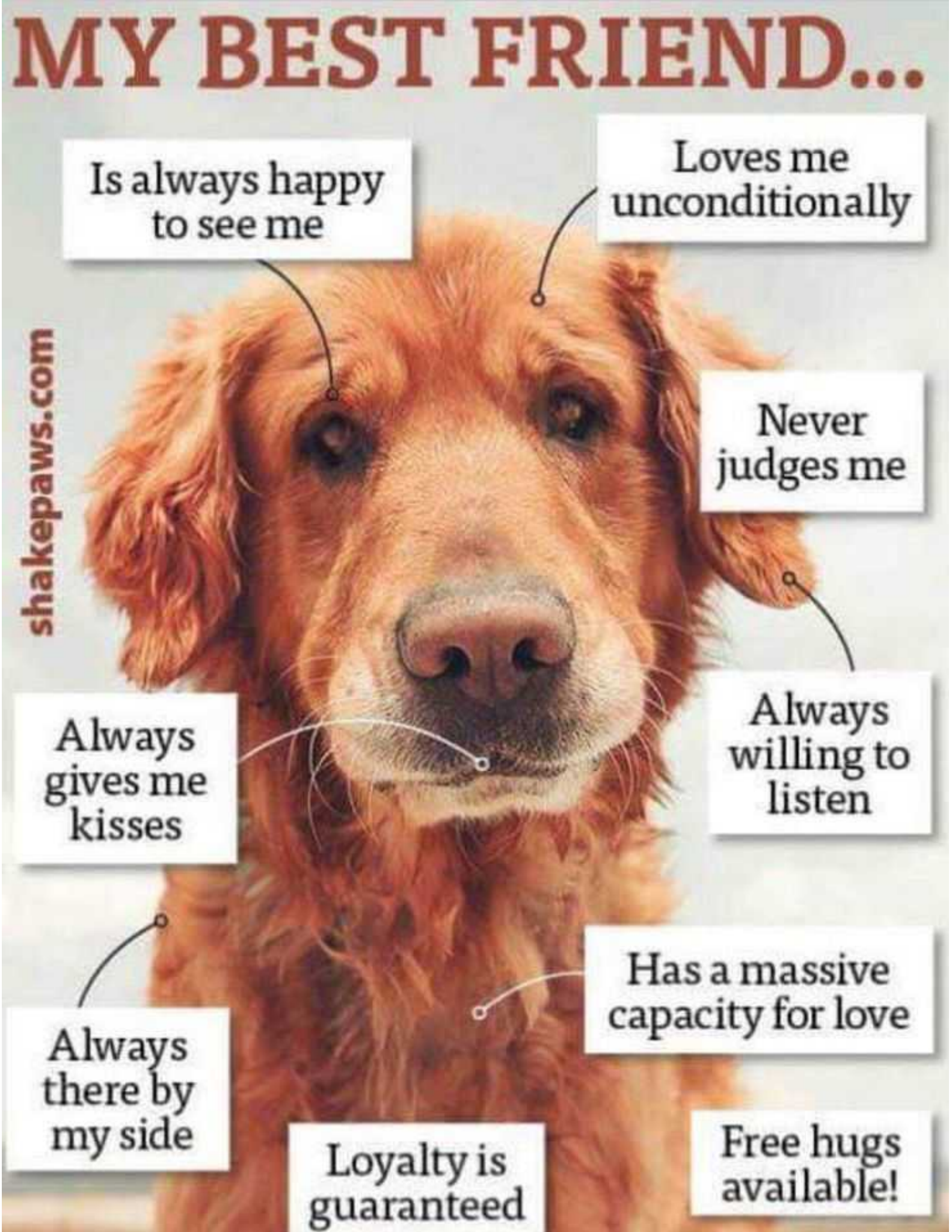

Research Into Audits/Improved Methods of Accounting and Next Steps

Motion to engage Chawla & Associates to review current financial posture, reinstate 501(c)3 tax exempt status and migrate to Quickbooks On-line



Research....

- As a new Treasurer, I have looked into options and ways we can improve.
- Request have been made for audits and we have looked into having this done pro-bono or at a reduced rate.
- Square/payments online and what is submitted to the Treasurer for classification for classes/membership is almost impossible to reconcile accurately in Quickbooks. This has proven to lead to inaccuracies and leaving a lot of questions unanswered.

Audit vs. Review

- Many conversations have been regarding audits/finances in past meetings as stated in our bi-laws we are to execute.
- It is suggested that the audit of books should be changed to review . An actual audit costs approximately \$6,000 and up . In today's terminology, an “audit” involves great scrutiny , insurance requirements, and liability by the auditor hence the expense. A review is \$2,000-\$3,000.

Motion to engage Chawla & Associates to review current financial posture

- Why?
 - Research has led to this group who do this very thing for nonprofits to assist with understanding our finances. They assist nonprofits of benefiting from advantages we may not be aware of.
- Who?
 - Roger Chawla- he works with a lot of different non-profits with over 20 years of experience.
- What has been learned?
 - Illinois Attorney General Reports- we need to file for the past 3-6 years as we have not filed state taxes as we believed we did not have to, but we needed to file forms with the Attorney General. There may be late penalties that need to be paid due to not filing the correct forms that are required. They can help us here.
 - 501 3C update would need to be done to have GABOC classified as a true nonprofit.
 - They can assist in the migration to QuickBooks online which will allow for clean, connected financial reporting.

501 3C Nonprofit Status

- The need to get our nonprofit, nontax 501 3C status back
 - We will not have to pay tax on things we buy.
 - This would enable us to obtain larger donations for our trials and raffles as contributors would be able to have a tax write off for those donations.
 - We would not have to pay property taxes if we had a building in the future where we could train more than one day a week.
 - This may open more opportunities for us as a true nonprofit to benefit in other ways from the community.
 - Allows us to apply for grants and other government assistance which is not taxable.



QuickBooks Online

- By using QuickBooks Online, Square could label transaction and auto load into QuickBooks Online providing traceability.
- Another advantage is that an accountant can review anywhere with the club at online meetings.
- Costs
 - QuickBooks Online Plus includes 5 users \$35 per month for first 3 months then \$70 monthly
 - QuickBooks Essentials \$20 per month for first 3 months, then \$40 monthly.

Summary of Priorities if we were to work with Chawla & Associates

- Get the books for migration to QuickBooks Online.
- See where 501-C3 status is and if it can be reinstated.
- Become current with the Attorney General's office.
- Timeframe should be summer completion.
- Then ask 2-3 people be on the finance committee and then decide the frequency of the audit.
- If we start shortly, this could be completed by summer.
- Once the 2020 work is settled, they can look back to see what else may need to be done.
