TREASURER'S REPORT

- 2. Thus far this year, we are -\$14.29.
- 3. Class income has, thus far, been good.
- 4. We now have a new flip phone. Sprint will continue to be our carrier. The phone will be given to Sandi Stephenson, who has agreed to accept GABOC calls.
- 5. The proposed 2020 budget had been distributed to those present for review.

At Gate Non-member from \$6,.00 to \$10.00

At Gate Second run - Member from \$3.00 to \$5.00

At Gate Second run - Non-Member from \$4.00 to \$5.00



- The Finance Committee recommended eliminating the salary of the Director of Training. Darlene Barnard made a motion that the salary of DOT be eliminated. Motion seconded. Eighteen members voted. Eight voted to eliminate the salary entirely; ten voted to keep the salary. Motion failed.



Training Tip

Think of your dog's **recall skills** like a **piggy bank**. Every time you call him, he comes and you reward him, you **put a bit of money into your piggy bank**.

It doesn't matter if it is just an **easy situation** like calling him in from the yard - the more often you can go through the process of **calling** - **listening** - **rewarding** the better and more ingrained the habit of coming when called will get.

Try to find a few opportunities **every day** in which you can rehearse it. It can even be as simple as calling him from one end of the house to the other.

Build up his desire to come to you by showing him over and over how well this works out for him.



O Dog Training Tips for Loose Leash Walking

- STOP! Don't move when your dog pulls. When you move when your dog pulls, your dog thinks it is because he pulled you. If you move only when there is no pressure on the leash, your dog will catch on quick!
- BEGIN TRAINING INSIDE if your dog pays no attention to you while out side. Lower distractions to teach your dog the skills to begin with and as your dog masters those new skills, slowly increase distractions.
- CLICK or m in the leas word with
 - CLICK or mark with a "yes!" whenever there is slack in the leash. Always follow your clicker or marker word with a yummy treat!
 - TALK to your dog! Talking to your dog helps your dog focus on you and not get too distracted by other stimuli. Dogs love having your attention and the interaction they can get from you for behaving.
 - As you increase distractions, increase the VALUE of the food you give as rewards. In higher distraction training sessions, make sure to use "human" food such as boiled chicken or hotdogs.



6 EVERY WALK IS A TRAINING SESSION. This means that until your dog walks well on leash, find other ways to exercise your dog. Bicycle rides, running on a treadmill, and obedience training are all good methods to drain energy!






