

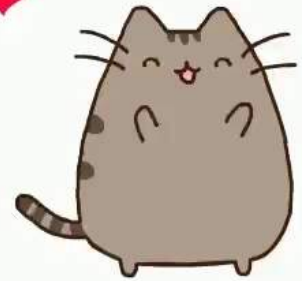

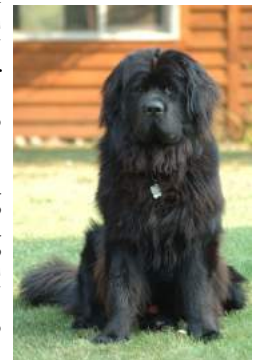
CANINE GOOD CITIZEN EVALUATION

Is your dog ready to be evaluated in order to earn his **Canine Good Citizen Title**? If you are attending one of our Beginner Classes you are already working toward that goal. However, graduating from a Beginner Classes in order to be evaluated is not a requirement. If you feel your dog is ready, pre-register to be evaluated. **The maximum number of dogs to be evaluated will be 10.** Make sure you are one of the first to sign up. Sign-up forms can be found on the GABOC website (GABOC.org), in this issue of Barks, or by asking your obedience instructor. The **Canine Good Citizen Program** teaches good manners to dogs and responsible dog ownership to their owners. The 10-step CGC test is a non-competitive test for all dogs, including purebreds and mixed breeds. It is a prerequisite for many therapy dog groups and some homeowner's insurance companies encourage CGC testing. There are also an increasing number of apartments and condos that require resident dogs to pass the CGC test.

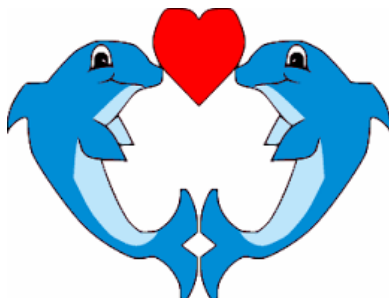

TREASURER'S REPORT

1. Donna Eichman reported that there are nine days until the end of the year. All expenses have been paid.
2. We lost \$3,310.74 in 2019.

FINANCE COMMITTEE

1. Joan Mazat, chairman reported that the Finance Committee met on November 21.
2. Joan also reported that the following people have agreed to serve on the committee: Sandi Stephenson, Chuck Holtzen, Laura Setar, Donna Eichman, Clara Luke, and Laura Plasketes

3. Financial Committee Findings as emailed by Joan Mazat:

- Rent- extremely high for what we are getting at \$19,600 annually (1,782 monthly). Compared to Fox Valley that pay \$2,100.00 monthly with 8 rings working from 5:00-9:30 p.m. We need to be looking for something to expand the scope of our offering. We need to be able to offer special classes, expand matches, use the building on other nights.
- Evaluate class price points in comparison to other clubs/outlets along with membership dues and propose pricing to allow us to be financially sustainable.
- Evaluate/negotiate costs **under this emergency time** until we are more solvent for awards, set up costs, DOT compensation.
- Seek to increase membership by increasing class attendance by offering discounted first time participants to GABOC through breed clubs, breeders, rescue groups, shelters, and to be included in vet puppy packages, etc.
- Make sure all events are really budgeted at historical income. **No events are allowed to lose any funds!** Committee chairs need to be responsible for maintaining budgets.
- Retain membership with a welcoming attitude by all members- be sure we are always patient, and offer mentoring.
- We will meet again in January for firmer direction on the points above.

DIRECTOR OF TRAINING

1. Liz Hixon reported that due to the fact that Francis Soresi has decided to give up instructing the 6:45 Beginner Class, the following changes have been made to both Beginner Classes: Susan Wooden, who was assisting Francis, will now assist Joanie; and, Gail Meyers will become head instructor in the 6:45 class. No assistant has been selected for that class.

REGISTRAR

1. Chuck Holtzen reported that at the moment, classes are at a low. One of the Beginner classes will carry over and resume January 6; and, there is no Puppy Class until January.

AWARDS

1. Jim reported that the Awards Committee will meet again after the holiday break.
2. Darlene Barnard has recommended a new vendor for plaques and title plates in order to save 50% over the cost of the previous award purchases.

WEBSITE

1. The introduction of the new website is currently on hold until Wix has another sale, which will be around December 2.
