# Member Highlight~ Gail Meyers

Hello, my name is Gail Meyers, and I am brand new member of GABOC. The club is not new to me, as I have heard many of my "dog" friends speak of it highly. I have shown my dogs in their Obedience Trials many times. When I got my latest puppy, a Dalmatian, I was looking for different places to train her. My friend Karen Heitz suggested that I try Glenbard. Since I had Monday evenings free I took her up on her suggestion and I am very glad that I did.




My children worry about me as I live alone in the house and wanted a dog for protection, so Liam, my GSD came to live with me. Forty-eight years ago, my husband and I were gifted a 6-week-old Dalmatian puppy, Murphy, for our wedding. My love for the Dalmatian was born. We lived in Norfolk, VA, as John was in the Navy. He was on a ship that was out to sea more than it was in port. So, looking for something to do with my time I decided to obedience train my puppy. A class was offered on the main Naval Base for sailors and their spouses and I decided to give it a try. Although we did not trial, Murphy only lived 3 years, it was then I was bitten by the training bug.

Life happened along with a couple of children. While we always had a dog, I didn't have time to train as I would have liked. One day my husband came home with a Basset Hound with orders from the breeder that "we" take it to obedience class. My career as a dog trainer began. My breeders were members of Lyons Township so that is where, in 1980, I entered Beginners Class. That Basset was the first of 7 dogs that I put CD's on, 2 of which were not my own. Other titles that my dogs and I have earned are CH, RN, CGC, CDX, Pet Partner (therapy) and Star Puppy. And while we did have the Basset we also had a GSD that was a house pet and child's friend. He was very well trained but never titled.

Some years later a friend of mine called with an offer to take one of her English Setter pups. My husband overheard me tell her that while I truly loved the look of the English Setter, if I was ever going to get a dog that I would put that much time and effort into training and showing, I'd rather go through that with a Dalmatian. Murphy had been gone for about 8 years, but secretly I had always wanted another Dalmatian. We were at the Christmas shows in Rosemont when I happened across the Dalmatian ring and started to chat with the exhibitors. It was just my luck that a litter was due soon with bloodlines I really liked. I asked to be called when the pups were old enough so I could go and see them. Well, they called. We went! I returned home with Ben our number 2 Dalmatian! He was my first CDX dog and my first film dog. I tried for a bench championship but never quite made it. Ben was everyone's friend! There was not one mean bone in his body and he became first Therapy Dog at Lyons. When my boy crossed over the Rainbow Bridge the club changed their therapy group name from "Visiting Pets" to "Ben's Friends". We go to schools, senior residents, libraries, hospitals...anywhere that a friendly dog will put a smile on the face of a "special" child or a senior. We help a child gain confidence in their reading or just let people pet a nonjudgmental, friendly dog. It is a program that is very near and dear to my heart. Two Bassets, 6 Dalmatians and 3 GSD's later, I am actively working with both of my Obedience Clubs. We train and work hard to promote "a well-trained dog is a happy dog" to just about everyone we meet.

That's my training life, and here's a little bit about me personally. I am a widow with two adult children. My son, the oldest, lives in Lombard and is soon to be married. My daughter, the youngest, lives in LA and is single. I work as a freelance animal wrangler for Animal Talent of Chicago. We provide animals for film, both moving and still. So, if I ever ask any of you if you'd let me take your dog's photo it is because we are looking for that type of dog for a photo shoot. I'm not kidding! In my spare time (what's that??) I can usually be found sitting at my sewing machine, making quilts or doing some other work that requires needle and thread. I love to read, go to lunch with friends and do projects around the house. And, my mom, at 95.5, is still very much alive and well. However, she does still need my help. I spend time with her at her apartment or at doctor appointments. I count my blessings that she is still alive and well enough to still enjoy her life. I keep myself very busy . . . you know "So much to do, so little time." I feel it keeps me young and happy.







# NO DAMP TRAMPS

If you use a garment like a dog sweater, always make sure it stays dry and change it if it becomes damp. Wet clothing can actually make a pet colder.



GET A CHECKUP

Bring your pet in for an exam. Cold weather can exacerbate health issues. so getting a checkup is important even for pets that seem healthy.



# MICROCHIP

Snow can affect a pet's sense of smell and ability to find their way, so microchip your pet and give them an identification tag so they can be returned to you.



CATS LOVE CARS

Cats are attracted to the warmth of cars, so make sure to always tap on the hood to alert any sleeping animals that could be injured when the car starts.





Cold weather can also result in some emergency situations like power outages. Make sure you have an emergency plan for your family that includes your pet.




