

* We need two judges (I can be one)


* We need at least two stewards to help set up, take gate entries, take down, and help clean up Advantages:

How do we keep our dogs fresh and challenged? Last month on day two at a trial, Windy looked at me like "not this again" and acted like she may have never done any of the exercises before. Sniffing stews, finding things on the floor, avoidance. What the heck? I know that all this is getting a bit old but hey, retirement means lack of exercise, speeding up the aging process, and watching the van depart with Mars when he goes to trial, her looking out the window crying and me sad in the driver seat. So, my job is to up the ante to add new twists and turns to make this a point of interest.... again! We know that at age 6 we won't be doing this for that much longer and need to move on but hey, there is one more title in OB to complete and there is that National competition in May I'd love to attend for the ARC!


So, we changed it up! Toys on the floor while doing utility. Food scattered on the floor while doing drop on recall and heelling. Making it harder, increasing focus. We started rally type doodling in heeling, spins, back ups, and unexpected moves. Results (so far) snorting and a few barks while heeling, ears up, spring in her step, and a bit of a look of "oh man, this food on the floor is a set up... don't touch!" - giving her a fresh sense of responsibility for her job. We'll see if this works at the March trials!

I also see this a bit in my novice class- a bit of tedium. Teams that have been with us for a while are seeking the next steps. So we are adding a sprinkle of open. Recall over the jump set low, sending over the jump for a treat and then recall back, command discrimination, and work on the first steps of taking it and out with the dumbbell. This has increased the interest of our human students and has made our furry friends super proud of their new found capabilities!

How do you keep it fresh? Me and Windy would love to hear your ideas?

On the opposite side, me and Mars are wondering what may be some new ideas to temper excitement in the ring to bring out the skills? Mars LOVES to trial and LOVES to work so this can hurt his scores as he acts like a fluffy nut! I have such a group of opposites!




